

Warranty

This warranty begins on date of delivery or pick-up and it extends to the original purchaser only. If your spa develops a defect that is covered under the terms of this warranty, it will be repaired by Fusion Pacific, Inc. (FPI) or its authorized dealer. The warranty does not cover any spa that has been subject to misuse, neglect, negligence, accident, civil disturbance, acts of God or that has been operated in any way contrary to the recommended operating instructions or that has not been installed as specified in the FPI operating manual. This warranty does not cover any spa that has been modified or altered except with parts or options that are authorized by FPI and installed according to recommended installation instructions. This warranty does not cover any spa that is being used for commercial purposes.

To obtain warranty service, contact your local authorized dealer or FPI for the name of your nearest dealer. You may be asked to provide original proof of purchase documents. FPI's responsibility with respect to warranty is limited to repairing or replacing and defective part(s), at its discretion, and FPI does not assume, nor does it authorize anyone else to assume any other obligation for it. FPI reserves the right to change or improve the design of any spa without obligation to modify any spa previously manufactured. All implied warranties, including merchantability and fitness for a particular purpose, are disclaimed in their entirety after expiration of the warranty period, with respect to parts or design.

- **1 Year Parts Warranty**

Spa parts, including the control head, top side control, pump, ozone generator, light housing, jets and plumbing are warranted to be free of defects or leaks for a period of one (1) year.

- **1 Year Labor Warranty**

Labor charges related to the repair or replacement of defective components, as listed in the parts section of this warranty, will be free of charge for a period of one (1) year. FPI's direct and only obligation to labor warranty is limited to the repair or replacement of defective parts that are returned to FPI for repair. The cost of removing, reinstalling and any related shipping charges are the responsibility of the spa owner. The spa owner may also be subjected to dealer trip charges.

- **5 Year Structural Warranty**

The structural integrity of the spa is warranted to be free of defects for a period of 5 (five) years. Should the spa structure develop a defect and not hold water within the warranty period, FPI will repair or replace the defective components of the spa. The cost of removing, reinstalling and any related shipping charges are the responsibility of the spa owner.

- **Incidentals**

Filter cartridges, light bulbs, LED lights, safety straps, cover seals and gaskets and all spa surfaces are warranted to be free of defects at time of delivery to the original purchaser, only.

- **Disclaimers**

FPI assumes no liability or responsibility for incidental, consequential or other damage including, but not limited to, removal of a deck or other custom fixture(s), transportation or shipping charges, telephone charges, rental of a like product during the time warranty service is being performed, travel, loss or damage to personal property and loss of revenue, use, time or inconvenience resulting from the loss of use of any spa covered by this warranty, as applicable by state laws.
